<p>1. Preliminary search</p> <p>A report will be issued to the requesting centre giving details of the HLA typing of matched (according to IBMDR criteria) and available adult donors and/or cord blood units (CBU).</p>	<p>free of charge</p>

HLA class II Typing</p> <p>HLA-DR typing of HLA-A and B adult matched donors, as selected by the requesting centre is performed by low resolution molecular typing.</p> <p><i>NB: class I typing will not be generally repeated at this stage. <p>5. Blood samples or DNA specimen procurement for final compatibility testing</p> <p>5.1 Procurement for each adult donor sample provided This fee includes donor interview session, donor out of pocket expenses, phlebotomy, blood packaging, infectious diseases markers testing (the donor's Infectious Disease Markers (Syphilis test, anti-HCV, HbsAg, anti-CMV IgG and IgM, anti-HIV 1 and 2 , ABO – Rh typing and general administrative charge.</p> <p>5.2 Sample shipment</p> <p><i>NB: The notice of cancellation of final compatibility test must be given ASAP in order to try to stop the shipment; if IBMDR is not able to cancel the shipment, the procurement fee will be charged.</i></p>	<p>€ 441,33</p> <p>Varies</p>
<p>6. Haematopoietic Stem Cell collection from bone marrow (HSC)</p> <p>6.1 Physical evaluation of the prospective donor This fee includes donor's anamnesis, health examination and laboratory tests.</p> <p>6.2 Bone marrow collection This fee includes the expenses related to the harvesting of bone marrow at an Italian harvesting centre. It covers the surgical operating room, the marrow collection team and, if necessary, the post-harvest donor's medical treatment and care.</p> <p>6.3 Donor costs This fee includes costs for pre-harvest counselling, procurement of the needed autologous units and covers also donor out-of-pocket expenses, donor insurance, the donor medical follow up (1 year after collection) and all administrative arrangements.</p> <p style="text-align: right;">Total cost of bone marrow HSC provision</p> <p>6.4 HSC transport to Transplant Centre</p>	<p>€ 399,79</p> <p>€ 16.096,25</p> <p>€ 503,96</p> <p>€ 17.000,00</p> <p>Varies</p>

HSC collection from peripheral blood (PBSC), after administration of growth factors</p> <p>7.1 Physical evaluation of the prospective donor This fee includes donor's anamnesis, health examination and laboratory tests.</p> <p>7.2 Administrations of growth factors (G-CSF) This fee includes the cost of growth factors plus cost of the physician.</p> <p>7.3 PBSC collection It includes costs of the collection and manipulation of stem cells at an Italian aphaeresis unit and the needed materials. It covers also, if necessary, the post-harvest donor's medical treatment and care</p> <p>7.4 Donor costs This fee includes costs of pre-collection counselling and the donor medical follow up (ten years after collection); it covers also donor out-of-pocket expenses, donor insurance and all administrative arrangements.</p> <p style="text-align: right;">Total cost of PBSC provision</p> <p>7.5 HSC transport to Transplant Centre</p>	<p>€ 688,91</p> <p>€ 1.704,70</p> <p>€ 13.728,65</p> <p>€ 877,74</p> <p>€ 17.000,00</p> <p>Varies</p>

<p>8. Cord Blood Unit</p> <p>8.1 Cord Blood Unit procurement</p> <p>It covers the cord blood unit procurement and all administrative arrangement. The TC may request the maternal plasma/serum, if available.</p> <p>8.2 HLA CBU confirmatory typing</p> <p>The CBU confirmatory typing is mandatory ; the HLA typing and identity of the unit must be confirmed as quality control before the release (A, B and DRB1* LR by molecular technique – 1 field).</p> <p style="text-align: center;">Total cost of CBU provision</p> <p>8.3 Procurement of DNA sample from Cord Blood unit</p> <p>The TC may request the shipment of a CBU reference sample (DNA or cryopreserved blood sample) if available. only if the CBU is selected for transplant. <p>9. HCS transplant cancellation / postponement</p> <p>If an official request of donor work-up or formal recruitment of the CBU has been received and the transplant is then cancelled or postponed a fee will be charged as detailed below.</p> <p>The listed fees represent the largest cost could be charged: each time the cancellation fee is calculated considering the services actually performed.</p> <p>9.1 After medical examination of adult donor</p> <p>Should a transplant be cancelled or postponed and the donor has undergone the medical examination, this fee will be activated. If the transplant does proceed and the donor does not require a second health evaluation, the initial cancellation charge will be deducted from the overall fee.</p> <p>Anyway, if it would be necessary to provide for the repetition of all, or part of, the services indicated at § 6.1 and 7.1 the respective costs will be charged joined to donor and other necessary costs.</p> <p>9.2 Before medical examination of adult donor</p> <p>This fee includes costs of pre-collection counselling, donor out-of-pocket expenses, and all administrative arrangements.</p> <p>9.3 Cancellation fee after administration of growth factors (per day)</p> <p>This fee includes the administrations of growth factors plus cost for the physician. It is calculated per day of G-CSF administration.</p> <p>9.4 Cancellation fee after formal recruitment of the cord blood unit</p>	<p>€ 1.227,87</p> <p>€ 398,96</p> <p>€ 324,54</p> <p>€ 1.227,87</p>

<p>10. Leukapheresis (not stimulated) after HSC donation</p> <p>Available only for IBMDR approved indications and from donors which gave their consent to this donation before the haematopoietic stem cells harvesting.</p>	
<p>10.1 Buffy coat collection from donor per session</p> <p>This fee includes donor's anamnesis, health examination, laboratory tests and donor medical follow-up. It includes costs of the collection and manipulation of stem cells at an Italian aphaeresis unit and the needed materials. It covers also donor out-of-pocket expenses, donor insurance and all administrative arrangements.</p>	<p>€ 538,00</p>
<p>Leukapheresis transport to Transplant Centre</p>	<p>varies</p>
